Reference	Type	Item
101.G	Updated	The school district makes menstrual hygiene products available, at no cost to students, in the bathrooms of every school building that is open for use by students in grades 4-12 during the regular school day.
101.I	New	The school district requires that any third-party online curriculum that is made available to enrolled students or the public complies with level AA of the World Wide Web Consortium's Web Consent Accessibility Guidelines 2.1 or any revised version of those guidelines.
101.J	New	The district allows a student to modify his or her athletic or team uniform for the purpose of modesty in clothing or attire that is accordance with the requirements of his or her religion or his or her cultural values or modesty preferences. A student is not required to receive the prior approval of the school board for such modification.
102.C	New	The district allows a dependent of United States military personnel who is housed in temporary housing located outside of the district to enroll if the dependent will be living within the district within 6 months after the time of initial enrollment and the military personnel seeking to enroll the dependent under this exception provides proof that the dependent will be living within the boundaries of the district within 6 months.
107	Updated	The district has a policy that all children enrolling in kindergarten and any student enrolling for the first time shall have an eye examination. Each child shall present proof by October 15 of each school year of having been examined by a licensed optometrist or by a physician licensed to practice medicine in all its branches within the previous year.
110.B	Updated	The district gives notice to the parents/guardians at least 60 days prior to May 15 of each school year that children in Kindergarten and the second, sixth and ninth grades must present proof of having been examined by the dentist before May 15th of the school year. If a child in the second, sixth, or ninth grade fails to present proof by May 15th, the school may hold the child's report card until one of the following occurs: the child presents proof of a completed dental examination, or the child presents proof that a dental examination will take place within 60 days after May 15th.
115	New	The district provides contact information for the National Suicide Prevention Lifeline and for the Crisis Text Line on the back of each student identification card issued by the school district. If the district does not issue student identification cards to its students or all of its students, this information is published on the district website.
116	New	The district complies with all requirements of the Student Online Personal Protection Act (SOPPA) including website requirements, reasonable security procedures, and policies.
308	New	The district has adopted a policy on absences and missed homework or classwork assignments as a result of or related to a student's pregnancy.
309	New	The district does not maintain a uniform or dress code policy that applies to hairstyles, including hairstyles historically associated with race, ethnicity, or hair texture, including but not limited to protective hairstyles such as braids, locks and twists.
402.A	Updated	A. During the academic year, each school conducts a minimum of: 3 school evacuation drills to address and prepare students and school personnel for fire incidents (1 of which must involve the participation of the fire department/district); 1 bus evacuation drill (accounted for in the district's curriculum); 1 severe weather and shelter in place drill to address and prepare students and school personnel for possible tornado incidents; and 1 law enforcement lockdown drill with the participation of law enforcement. The law enforcement lockdown drill must be conducted no later than 90 days after the first day of each school year and the district must comply with all of the requirements of Public Act 102-0395 related to the administration of this drill and the treatment of students who do not participate in the this drill



403 Updated

The district has an anaphylactic policy, parents and guardians have been notified of the policy, and the district has implemented or updated its policy, as appropriate, in accordance with any anaphylactic policy developed by the State Board pursuant to Public Act 102-0413

509.AD New

The district provides at least 30 minutes of supervised, unstructured, child-directed play time for all students in grades K-5 in any school day that is 5 clock hours or longer in length, and play time for at least.one-tenth of the total time for attendance for any school day that is less than 5 clock hours in length. The district does not allow the withholding of play time as a disciplinary or punitive action, except when a student's participation in play time poses an immediate thread to the safety of the student or others.

509.AE New

If the district offers comprehensive personal health and safety and comprehensive sexual health education courses, then the district annually posts the curriculum on its website (if one exists) and provides the name and contact information, including an email address, of school personnel who can respond to inquiries about instruction and materials. In addition, the course materials and instruction meet all of the requirements outlined in Public Act 102-0522, including but not limited to the following:1. Aligned to the National Sex Education Standards and any additional standards adopted by ISBE.2. Accessible to students with disabilities through any needed modifications.3. Inclusive and sensitive to the needs of students based on their status as pregnant or parenting; living with STIs, including HIV; sexually active; asexual or intersex; survivor of interpersonal violence and sexual violence; or based on their gender, gender identity, gender expression, sexual orientation, sexual behavior, or disability.

509.G.6 New

The study of the contributions made to society by Americans of different faith practices, including, but not limited to, Muslim Americans, Jewish Americans, Christian Americans, Hindu Americans, Sikh Americans, Buddhist Americans, and any other collective community of faith that has shaped America

509.S.3 New

The district excuses any student from engaging in any physical activity components of a physical education course during a period of religious fasting if the student's parent or guardian notifies the school principal in writing that the student is participating in religious fasting. The district also honors excuses signed by persons licensed under the Medical Practice Act of 1987, and has adopted a policy defining the types of parental excuses it will deem appropriate, which must include, but not be limited to, reliance upon religious objections. If the board has established a policy to excuse students from physical education for any other reason, the policy allows for students to be excused only for those reasons and grade levels as authorized by statute.

509.S.4 New

The district excuses pupils in grades 3-8 from engaging in physical education courses if those pupils must utilize the time set aside for physical education to receive special education support and services.

509.T.2 Updated

The health education program shall include, but is not limited to, the following major areas as a basis for curricula in allelementary and secondary schools: human ecology and health; human growth and development; the emotional, psychological, physiological, hygienic and social responsibilities of family life including sexual abstinence until marriage; prevention and control of disease, including instruction in grades 6 through 12 on the prevention, transmission and spread of AIDS; age-appropriate sexual abuse and assault awareness and prevention education in grades pre-kindergarten through 12; public and environmental health; consumer health; safety education and disaster survival; mental health and illness; personal health habits; alcohol and drug use and abuse, including the medical and legal ramifications of alcohol, drug, and tobacco use; abuse during pregnancy; evidence-based and medically accurate information regarding sexual abstinence; the dangers of tobacco and e-cigarettes and other vapor device use; nutrition; and dental health. 510.AA New

If the district offers comprehensive personal health and safety and comprehensive sexual health education courses, then the district annually posts the curriculum on its website (if one exists) and provides the name and contact information, including an email address, of school personnel who can respond to inquiries about instruction and materials. In addition, the course materials and instruction meet all of the requirements outlined in Public Act 102-0522, including but not limited to the following:1. Aligned to the National Sex Education Standards and any additional standards adopted by ISBE.2. Accessible to students with disabilities through any needed modifications.3. Inclusive and sensitive to the needs of students based on their status as pregnant or parenting; living with STIs, including HIV; sexually active; asexual or intersex; survivor of interpersonal violence and sexual violence; or based on their gender, gender identity, gender expression, sexual orientation, sexual behavior, or disability.

510.E.5 New

The study of the contributions to society by Americans of different faith practices, including, but not limited to, Muslim Americans, Jewish Americans, Christian Americans, Hindu Americans, Sikh Americans, Buddhist Americans, and any other collective community of faith that has shaped America

510.P Updated

The health education program shall include, but is not limited to, the following major educational areas as a basis for curricula in all elementary and secondary schools: human ecology and health; human growth and development; the emotional, psychological, physiological, hygienic and social responsibilities of family life including sexual abstinence until marriage; prevention and control of disease, including instruction in grades 6 through 12 on the prevention, transmission and spread of AIDS; age-appropriate sexual abuse and assault awareness and prevention education in grades pre-kindergarten through 12; public and environmental health; consumer health; safety education and disaster survival; mental health and illness; personal health habits; alcohol and drug use and abuse, including the medical and legal ramifications of alcohol, drug and tobacco use; abuse during pregnancy; evidence-based and medically accurate information regarding sexual abstinence; the dangers of tobacco and e-cigarettes and other vapor device use; nutrition; and dental health. Training on how to properly administer cardiopulmonary resuscitation (which training must be in accordance with standards of the American Red Cross, the American Heart Association, or another nationally recognized certifying organization) and how to use an automated external defibrillator shall also be included as a basis for curricula in all secondary schools in this State

510.Q.2 Updated

The district excuses any student from engaging in any physical activity components of a physical education course during a period of religious fasting if the student's parent or guardian notifies the school principal in writing that the student is participating in religious fasting. The district also honors excuses signed by persons licensed under the Medical Practice Act of 1987, and has adopted a policy defining the types of parental excuses it will deem appropriate, which must include, but not be limited to, reliance upon religious objections. If the board has established a policy to excuse students from physical education for any other reason, the policy allows for students to be excused only for those reasons and grade levels as authorized by statute.

511.A.5 Updated

Two years of social studies, of which at least one year must be in a history of the U.S. or a combination of U.S History and American Government and, beginning with pupils entering the 9th grade in the 2016-2017 school year at least one semester of which must be Civics. Beginning with pupils entering the 9th grade in the 2021-2022 school year and each school year thereafter, one semester, or part of one semester, may include a financial literacy course.

511.A.6 Updated

One year chosen from (a) music, (b) art, (c) foreign language, which shall be deemed to include American Sign Language, (d) vocational education, or (e) forensic speech (speech and debate). A forensic speech course used to satisfy the graduation requirement for four years of language arts may not be used to satisfy this graduation requirement.

516.B New

Prior to the placement of a child in an out-of-state special education residential facility, the school district offers the child or the child's parent or guardian the option to place the child in an Illinois facility, if any, that provides treatment and services comparable to those provided by the out-of-state facility. The school district conducts an annual review of any child's out-of-state placement and offers the child or the child's parent or guardian the option to place the child in an in-state comparable facility, if any.
